Circular no. L&M (PPRA) 10-01/2011 dated 10-02-2020 issued by PPRA states that, in case of the procurement through prequalification mode the procuring agency must ensure at least three (03) pre-qualified bidders are available for further process and it was observed that only one bidder was qualified. Therefore, it was decided to obtain advice from PPRA as proposed consultancy is unique and time bound in nature. In light of the advice of the PPRA vide letter No.&GAD No. L&M (PPRA)1-13(G)/2023, Dated 29th November (annex-A), the Committee announced that Dr. Muhammad Ayub is the only responsive consultant who fulfils the criteria of expression of interest out of 03 consultants. The committee with unanimous decision recommended that RFPs may be issued to shortlisted responsive consultant (Dr. Muhammad Ayub).
