Project titled "Implementation of master plan of safari zoo Lahore" has been approved by the PDWP, dated, 20-09-2023 at a total cost of Rs. 2453.200 million. Purchase of animals is a vital component of the project, which as per feasibility report is divided into national and international purchase categories.

For the purchase of animals under international category, the animals have been grouped into 08 lots. As the estimated cost of all the lots exceeds 100 million, therefore as per provision of PPRA Rules, process of pre-qualification of firms have been completed. An advertisement to this effect was floated in national newspapers (IPL 9238), International newspapers (SPL1826), PPRA website and website of the Punjab Wildlife and Parks Department.

The submission of prequalification documents was held at the office of the Director Lahore Zoo Lahore on 26-12-2023. The documents were opened and handed over to Engineering Consultancy Services Punjab in the presence of each committee member on 26-12-2023 at the office of the Lahore Zoo Lahore

Engineering Consultancy Services Punjab completed the evaluation and presented a detailed report on 28-12-2023 at the office of the Director Lahore Zoo Lahore. The committee recommended evaluation of the prequalification for supply of wild animals through international competitive bidding as per recommendation of the Engineering Consultancy Services Punjab (ECSP).

Total 05 number of applicants submitted the applications for all 8 No. of lots, whereas, the results of evaluation are summarized as:
