NOTIFICATION

Project titled "Implementation of master plan of safari zoo Lahore" has been approved by the PDWP, dated, 20-09-2023 at a total cost of Rs. 2453.200 million. Purchase of animals is a vital component of the project, which as per feasibility report is divided into national and international purchase categories. For the purchase of animals under national category, the animals have been grouped into 04 lots. As the estimated cost of all the lots exceeds 100 million, therefore as per provision of PPRA Rules, process of pre-qualification of firm was started. An advertisement to this effect was floated in national newspapers (IPL 9237), PPRA website and website of the Punjab Wildlife and Parks Department.

Total 05 numbers of the firms were participated in the Pre-qualification process, out of 05 firms 03 firms namely, M/S Animal Planet, M/S Hanif and Engineering Co, and Zarrar and Co. were prequalified for all 04 lots, 01 firm namely, Barlex Agency was prequalified for only 01 lot (Lot No. 04), while, 01 firm, Zain Enterprises disqualified in Pre-qualification. RFPs issued to the prequalified bidders against their respective lots on 08-12-2023.

The submission of RFPs documents held at the office of the Director Lahore Zoo Lahore on 23-12-2023. The documents were opened and handed over to Engineering Consultancy Services Punjab in the presence of each committee member at the office of the Director Lahore Zoo Lahore.

Engineering Consultancy Services Punjab has completed the evaluation of RFPs (Technical) and furnished a detailed report. The committee approved the evaluation report submitted by the Engineering Consultancy Services Punjab. The results of evaluation are summarized as:
